The adopter hereby releases and forever discharges Safe Haven and its representatives from any actions, cause of actions, suits, liabilities, claims, demands, damages or causes of any kind. Whether presently existing or arising in the future. The adopter is to be solely responsible for this animal and any damages that may result from its actions. The adopter is responsible for the costs of any medical conditions that may arrise in the future.

Adopters Obligations

You must notify Safe Haven ***IMMEDIATELY*** if the animal is lost or stolen.

If for any reason the adoption is not satisfactory or if health/life changes make it necessary to give up the animal it must be **returned** to Safe Haven. It cannot be transferred to any other person or organization for **any** reason.

You **must** notify Safe Haven of changes in address or phone number.

The animal will reside **indoors** as a family member and cannot be outdoors without proper supervision.

You agree to abide by all state and local animal control and leash laws. It is **your** responsibility to become familiar with these laws.

The animal must receive proper veterinary care. Including yearly check-ups and the use of preventatives. Adequate food and water must be supplied on a regular basis.

The animal cannot be crated for more than **8** hours a day.

The animal must wear rabies tag, license (where necessary) and identification at all times.
